

IQM National Quality Expert (NQE) Programme

1) Policy and Aim

- 1.1 It is the policy of IQM to promote Quality in all aspect of business including the promoting of eminent IQM Members with Special Quality expertise in a specific field or sector of business.
- 1.2 IQM hereby establish a programme under IQM-MRCA Scheme to identify, select and nominate a Member with Special Quality expertise to be a **National Quality Expert (NQE)**, in each field or sector.
- 1.3 The aim is to recognize prominent IQM peer and support him/her with elevated position to compete in the global Quality industry and business.

2) Nomination and Approval

- 2.1 IQM Board Members are entrusted with the task to nominate their peers to the relevant field or sector as a National Quality Expert (NQE). Such nominated candidate shall be approved by Majority of the Board Members.
- 2.2 In the event there is more than one Expert in the same field then they shall be differentiated with separate sub-fields or sub-sectors.

3) Terms & Conditions

- 3.1 The nominee shall be a valid IQM Member with a good knowledge on Special Quality expertise in specific field or sector of business.
- 3.2 The nominated or approved candidate (NQE) may serve in IQM professional **Dispute Resolution Committee** whenever necessary.
- 3.3 IQM may propose such candidate (NQE) to represent IQM in the Malaysia National Industry Standards Committee or request by Authority or Government Department or any National Technical Committee.
- 3.4 IQM may propose such candidate (NQE) to represent IQM in any International Conference or Seminar.
- 3.5 IQM shall have the right to include the name of such NQE in any IQM publication, newsletter, letter head, brochure or any other relevant official documents.

4) Certificate and Duration

4.1 A Certificate of **National Quality Expertise** will be issued to such IQM National Quality Expert (NQE) with the specific field or sector described therein. A minimal fee may be charged to cover the stationery and administration expenses.

- 4.2 The validity for each Certificate shall be for a period of three (3) years. Unless the NQE resign from such nomination prior to expiry or whenever such NQE is no longer a valid member of IQM according to the IQM Rules and Constitution.
- 4.3 The Certificate validity may be extended for another three (3) years by the Board of Management whenever they think fit.

5) Register

IQM Secretariat will keep a Register of the NQE candidates within the IQM-MRCA Scheme.

This Register shall be a reference for any external parties or IQM Members who wish to verify the status of IQM National Quality Experts.


